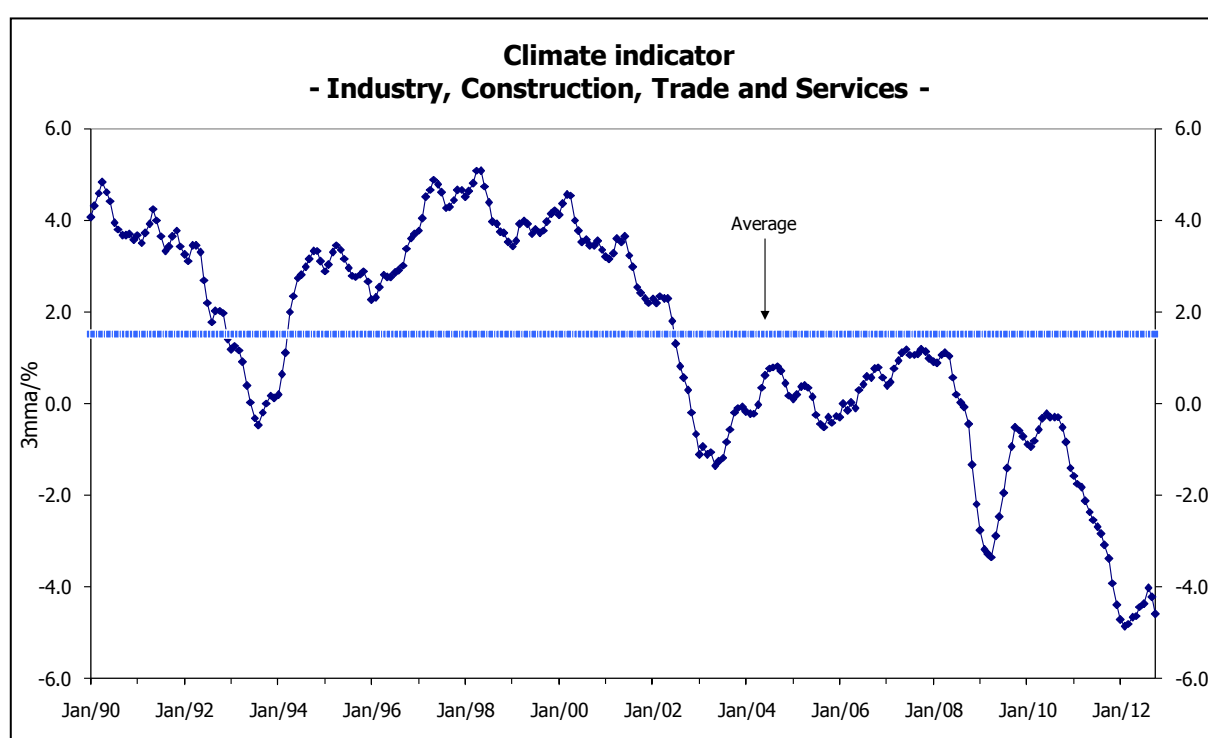
The consumer confidence and the economic climate indicators diminish again

The Consumer confidence indicator decreased in the last two months, more intensely in October, interrupting the upward movement started in February.

The economic climate indicator diminished in September and October, more significantly in the last month, opposing the positive path started in March. In the last two months, the confidence indicators decreased in all the sectors, Manufacturing Industry, Construction and Public Works, Trade and Services.

The decrease in the Consumer¹ confidence indicator observed in the last two months resulted from the negative contribution of all components, in particular the perspectives on the evolution of the country's economic situation and of the households' financial situation. In monthly values, without considering three months moving averages, this indicator attained the lowest value of the series in October.

In Manufacturing Industry, the confidence indicator diminished in September and October due to the negative contribution of the opinions on global demand and, mainly, of the production perspectives, while the opinions on the stock of finished goods' evolution contributed positively. The confidence indicator for Construction and Public Works declined again, led by the reduction of both components, opinions on the order books' evolution and employment perspectives, stronger in the first case. The confidence indicator for Trade diminished in September and October, as a result of the reduction observed in both subsectors, Wholesale and Retail Trade. The Services' confidence indicator decreased significantly in October, attaining the lowest value of the series, led by the negative contribution of all components, opinions on the business activity and on the order books' evolution and demand perspectives, more pronounced in the second case.



¹ Unless stated otherwise, the analysis in this press release refers to three-month moving averages for the monthly variables and to two-quarter moving averages for the quarterly ones.

NOTES

The text and graphics of this press release are based on three terms moving averages, for the monthly variables, and two terms, for the quarterly variables, and on original values, except the cases of the seasonally adjusted series. The seasonal adjustment uses the X12-Arima method (combination of moving averages process and auto-regressive integrated moving average models) developed in the Demetra software provided by Eurostat. This application relies on the use of probabilistic models to correct seasonal effects from the original series. Periodically, the inclusion of additional data determines the need to estimate new probabilistic models, which can lead to revisions to the previously published series. The use of moving averages smoothes out the series by removing the irregular movements, allowing the detection of the short-term trends. Since the average is not centred (the information is used to analyse the evolution of the last month) there is a small lag compared with the trend that is supposed to detect.

In order to compare the difference between original and moving average series, the graphical representation of the confidence indicators presents both types of series.
