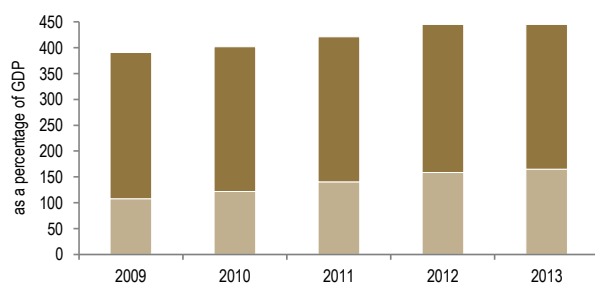

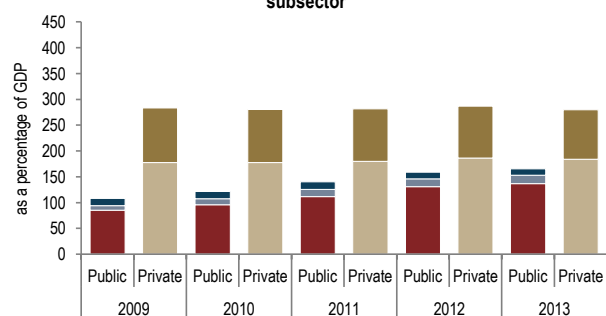

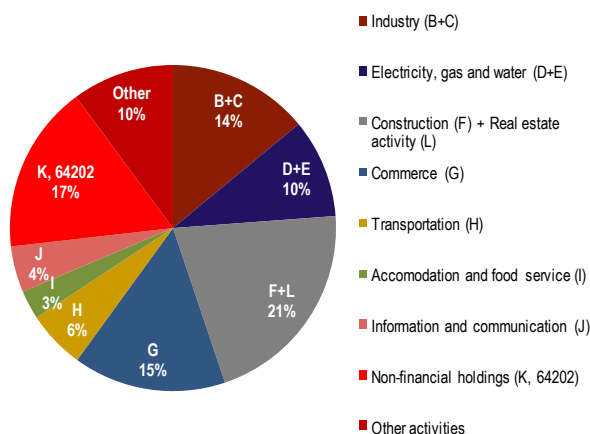

Non-financial sector indebtedness: public and private, by subsector

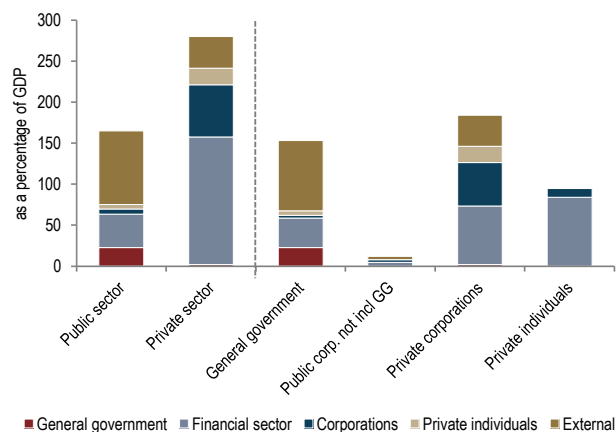


■ General govern. excl. public corporations ■ Public corp. incl GG
