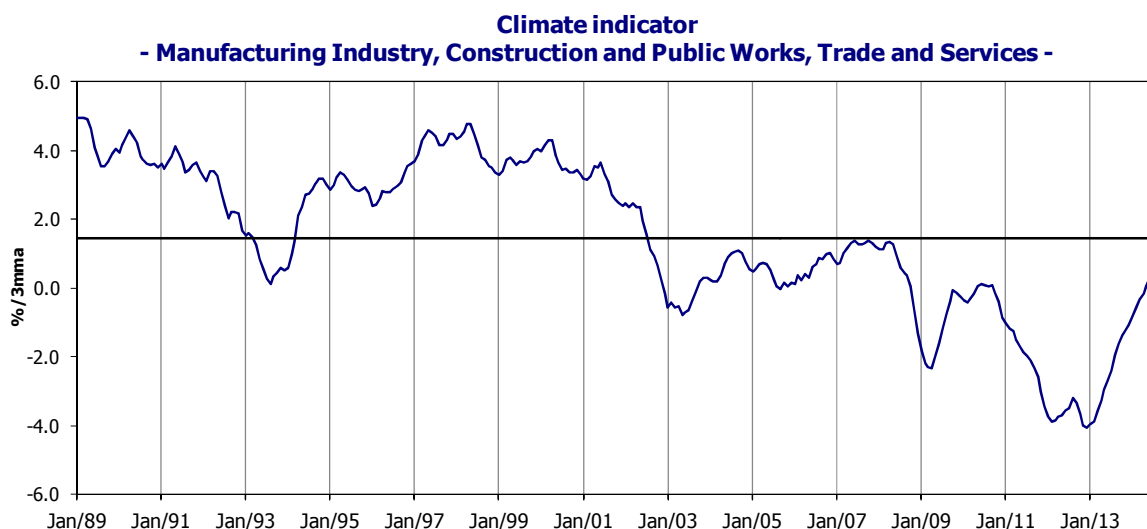
The Consumer confidence indicator decreases and the economic climate indicator increases

The Consumer confidence indicator slightly decreased in August, after recording the maximum value since January 2007, suspending the pronounced upward movement observed since the beginning of 2013.

The economic climate indicator recovered slightly in the reference month, maintaining the positive path started in January 2013 and attaining the maximum since July 2008. In August, the confidence indicator has increased in Manufacturing Industry, Construction and Public Works and Services and decreased in Trade.

The reduction of the Consumer¹ confidence indicator in August was driven by the negative contribution of the perspectives on the savings and the country's economic situation evolution.

In Manufacturing Industry, the confidence indicator increased in the last two months, attaining the maximum since September 2008, led by the positive contribution of the opinions on global demand evolution, as the production perspectives and the stock of finished products' contributed negatively. The confidence indicator for Construction and Public Works slightly recovered in August, maintaining the upward movement begun in December 2012 and attaining the maximum since November 2010. The behaviour of this indicator in the reference month reflected the recovery of the opinions on the order books' evolution. On the other hand, the confidence indicator for Trade diminished in the last three months, reflecting in August the negative contribution of the perspectives on the business activity and of the opinions on the sales, more intense in the first case, while the opinions on the volume of stock evolution contributed positively. The Services' confidence indicator increased tenuously in August, extending the intense positive movement observed since the end of 2012 and recording the maximum since June 2008. In the reference month, the opinions on the business activity and the demand perspectives recovered, more significantly in the second case.



¹ Unless stated otherwise, the analysis in this press release refers to three-month moving averages for the monthly series and to two-quarter moving averages for the quarterly ones.

Notes

The Business and Consumer Qualitative Surveys published by Statistics Portugal are developed in the framework of the harmonized EU Business and Consumer Surveys Programme of the European Commission (EC) DG-ECFIN (*Directorate-General for Economic and Financial Affairs*) and are financially supported in the framework of the agreement signed between these two institutions. The questionnaires are harmonized among the European countries, as well as the respective confidence indicators' methodology. The surveys' results are sent to the EC in effective values, and, therefore, the seasonally adjusted values published by the EC are computed by this entity and presented without using three months moving averages. The seasonal adjustment method used by the EC is available on the user guide, accessible in:

The text and graphics of this press release are based on three terms moving averages, for the monthly variables, and two terms, for the quarterly variables, and on original values, except the cases of the seasonally adjusted series. The seasonal adjustment uses the X13-Arima method (combination of moving averages process and autoregressive integrated moving average models) developed in the JDemetra+² software provided by Eurostat. This application relies on the use of probabilistic models to correct seasonal effects from the original series. The seasonal treatment is updated in August, for the monthly series, and in October, for the quarterly series, which might result on a revision of the series previously published. The use of moving averages smoothes out the series by removing the irregular movements, allowing the detection of the short-term trends. Since the average is not centred (the information is used to analyse the evolution of the last month) there is a small lag compared with the trend that is supposed to detect.

In order to compare the difference between original and moving average series, the graphical representation of the confidence indicators presents both types of series. The average of the economic climate indicator is computed from the beginning of the series to the reference month.

The balances of the questions are the difference between the positive and negative answers, that is $\text{Balance} = \% \text{answer (+)} - \% \text{answer (-)}$. In the Consumer Survey there are questions with more than one option of positive/negative answer. In these cases, to the most positive/negative answers is given the weight 1 and to the others the weight 0.5, that is $\text{Balance} = [\% \text{answer (++)} * 1 + \% \text{answer (+)} * 0.5] - [\% \text{answer (--)} * 1 + \% \text{answer (-)} * 0.5]$. The percentage of answers that correspond to "equal" is not considered.

ECONOMIC CLIMATE INDICATOR

Synthetic Indicator estimated using balances of questions from the Manufacturing Industry, Trade, Construction and Public Works and Services Surveys. The method for this indicator uses the factor analysis and the estimated series (the common component) is calibrated using the GDP change rates. The questions that integrate the indicator are:
