

Discretionary Asset Management (Mandates)¹ – November 2014

On November 30, 2014, the total amount of the discretionary accounts (mandates) stood at EUR 57,543.9 million, which reflects an increase of 1.0 percent from the previous month.

Since end December 2013, Total Net Asset Value of discretionary accounts rose by 5.5 percent, while since November 2013 there has been an increase of 5.8 percent.

Management Companies

In November 2014, Caixagest was the Management Company with the largest market share, with total net assets standing at EUR 21,351.6 million, which represents 37.1 percent of the total. F & C Portugal ranks second, with total net assets of EUR 13,874.0 million and a market share of 24.1 percent, and ESAF – GP ranks third, with EUR 7,055.8 million of assets under management and a market share of 12.3 percent.

Dunas Capital - Gestão de Activos was the Management Company that registered the highest growth, with a 14.9 percent increase over the previous month (EUR 4.0 million). The largest growth in total net assets belonged to BPI Gestão de Activos that increased EUR 294.0 million (4.6 percent).

Since end December 2013, Dunas Capital - Gestão de Activos is, also, the Management Company registering the highest percentage growth with 44.7 percent (EUR 9.6 million), while BPI Gestão de Activos is, also, the Management Company with the largest increase in total net assets with EUR 1 914.9 million (40.1 percent).

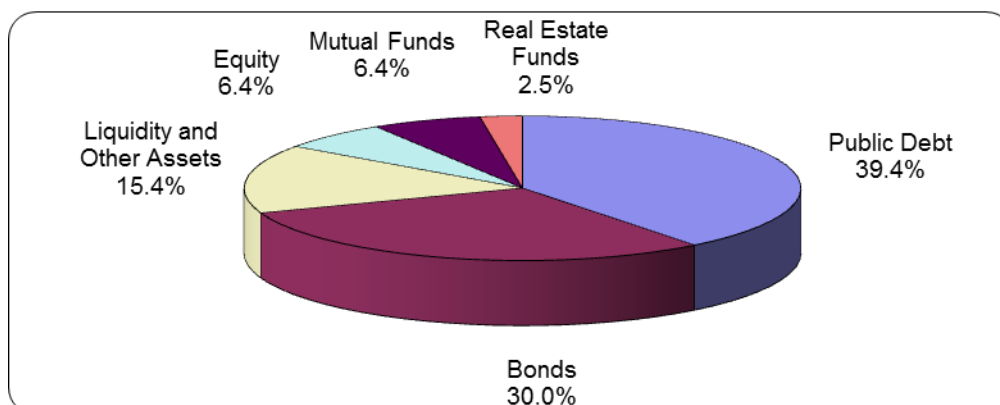

Discretionary Asset Management's Clients

Regarding the residence of clients, 97.6 percent of assets under management are related to Portuguese investors.

The majority of the portfolios under management belonged to Insurance Companies (67.0 percent of the total), followed by Pension Funds (17.3 percent of the total) and by Other Investors (12.1 percent of the total).

Discretionary Asset Management's Portfolio

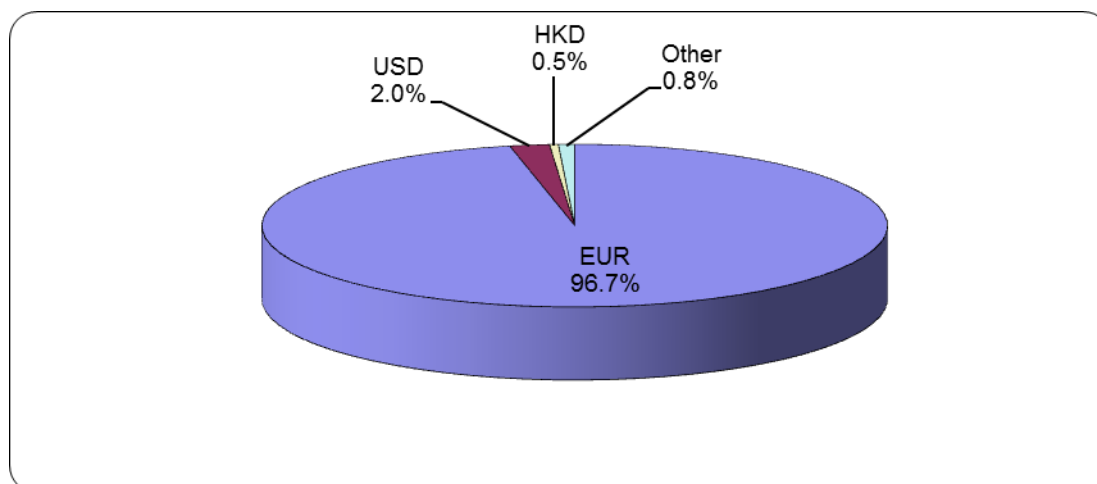


In November 2014, Public Debt was the asset class with the biggest weight in the portfolios of Discretionary Asset Management representing 39.4 percent of the total holdings. Corporate Bonds came second with 30.0 percent of total holdings.

During this month, Public Debt registered the highest increase in total assets' share, up 0.5 p.p. from the previous month.

Since end December 2013, Public Debt is the asset class with the highest growth in Discretionary Asset Management's portfolio, rising from 32.8 percent to 39.4 percent.

In November 2014, 96.7 percent of the assets held in the Discretionary Asset Management portfolios were denominated in Euro, 2.0 percent in US Dollar and 0.5 percent in Hong Kong Dollar.
