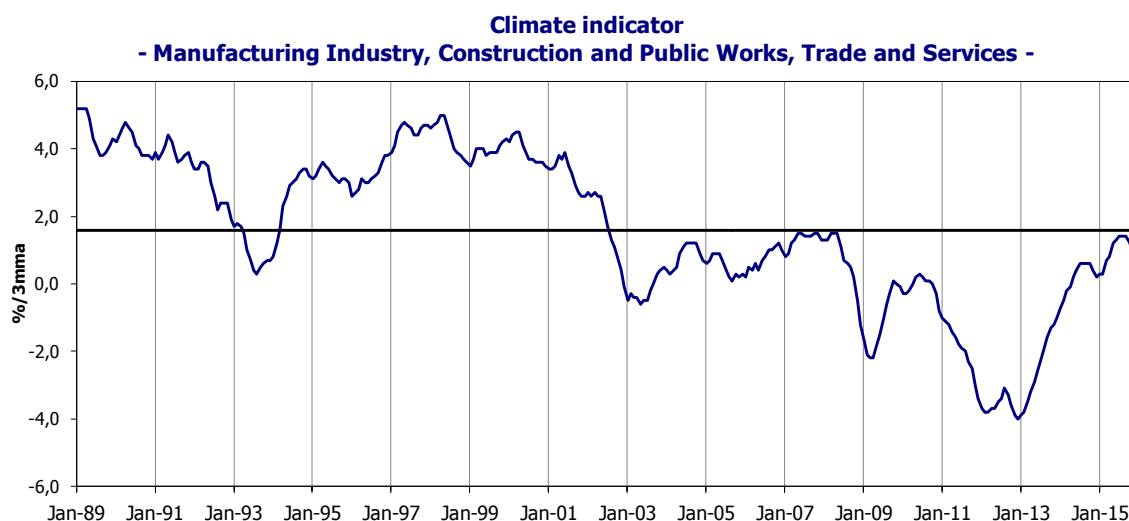
**The economic climate and the consumer confidence indicators decrease**

The Consumer confidence indicator diminished significantly in November, after stabilizing in the maximum value since April 2001, reversing the upward trend started in the beginning of 2013.

The economic climate indicator decreased in October and November, after stabilizing in the two previous months. In the reference month, the confidence indicator diminished in all sectors, Manufacturing Industry, Trade, Construction and Public Works and Services, more significantly in the last two cases.

The decrease of the Consumer<sup>1,2</sup> confidence indicator in November resulted from the negative contribution of all components, mainly the perspectives of the country's economic situation.

In Manufacturing Industry, the confidence indicator slightly diminished in November, due to the negative contribution of the opinions on global demand and on the stocks of finished products' evolution, stronger in the first case, while production perspectives contributed positively. In Construction and Public Works, the confidence indicator decreased significantly in the reference month, following the negative behaviour of all components, employment perspectives and opinions on the order books' evolution. The confidence indicator for Trade slightly diminished in November, reflecting the negative contribution of the opinions on the volume of stocks, as the opinions on the sales evolution and the perspectives on the business activity contributed positively. The Services' confidence indicator decreased significantly in the last month, due to the negative behaviour of the opinions on the business activity and on the order books' evolution, stronger in the first case.



<sup>1</sup> Unless stated otherwise, the analysis in this press release refers to three-month moving averages for the monthly series and to two-quarter moving averages for the quarterly ones.

<sup>2</sup> It must be noticed that, from this publication onwards, the information from the Qualitative Consumer Survey is based in a new sample.

## Notes

The Business and Consumer Qualitative Surveys published by Statistics Portugal are developed in the framework of the harmonized EU Business and Consumer Surveys Programme of the European Commission (EC) DG-ECFIN (*Directorate-General for Economic and Financial Affairs*) and are financially supported in the framework of the agreement signed between these two institutions. The questionnaires are harmonized among the European countries, as well as the respective confidence indicators' methodology. The surveys' results are sent to the EC in effective values, and, therefore, the seasonally adjusted values published by the EC are computed by this entity and presented without using three months moving averages. The seasonal adjustment method used by the EC is available on the user guide, accessible in:

**The text and graphics of this press release are based on three terms moving averages, for the monthly variables, and two terms, for the quarterly variables, and on original values, except the cases of the seasonally adjusted series. The seasonal adjustment uses the X13-Arima method (combination of moving averages process and autoregressive integrated moving average models) developed in the JDemetra+<sup>3</sup> software provided by Eurostat. This application relies on the use of probabilistic models to correct seasonal effects from the original series. The seasonal treatment is updated in August, for the monthly series, and in October, for the quarterly series, which might result on a revision of the series previously published. The use of moving averages smoothes out the series by removing the irregular movements, allowing the detection of the short-term trends. Since the average is not centred (the information is used to analyse the evolution of the last month) there is a small lag compared with the trend that is supposed to detect.**

**In order to compare the difference between original and moving average series, the graphical representation of the confidence indicators presents both types of series. The average of the economic climate indicator is computed from the beginning of the series to the reference month.**

The balances of the questions are the difference between the positive and negative answers, that is  $\text{Balance} = \% \text{answer (+)} - \% \text{answer (-)}$ . In the Consumer Survey there are questions with more than one option of positive/negative answer. In these cases, to the most positive/negative answers is given the weight 1 and to the others the weight 0.5, that is  $\text{Balance} = [\% \text{answer (++)} * 1 + \% \text{answer (+)} * 0.5] - [\% \text{answer (--)} * 1 + \% \text{answer (-)} * 0.5]$ . The percentage of answers that correspond to "equal" is not considered.

### ECONOMIC CLIMATE INDICATOR

Synthetic Indicator estimated using balances of questions from the Manufacturing Industry, Trade, Construction and Public Works and Services Surveys. The method for this indicator uses the factor analysis and the estimated series (the common component) is calibrated using the GDP change rates. The questions that integrate the indicator are:
